PDSA WAS VERY ACTIVE ON THE ADVOCACY FRONT, WITH STAFF AND MEDICAL ADVISORS MEETING WITH DIRECTORS FROM THE DIVISION OF BLOOD DISORDERS AT BOTH THE NHLBI (NATIONAL HEART, LUNG AND BLOOD INSTITUTE) AND THE CDC (CENTERS FOR DISEASE CONTROL AND PREVENTION). WE ORGANIZED TWO HILL DAYS IN WASHINGTON, DC, MEETING WITH 26 CONGRESSIONAL OFFICES TO EDUCATE THEM ON THE UNMET NEEDS AND BURDEN OF DISEASE OF ITP PATIENTS AND URGING THEM TO SUPPORT FEDERAL PROGRAMS FOR ITP. DUE TO OUR EFFORTS, THE DEPARTMENT OF HEALTH AND HUMAN SERVICES INCLUDED ITP REPORT LANGUAGE IN SENATE APPROPRIATIONS BILL - A FIRST! THIS MEANS THAT CONGRESS HAS RECOGNIZED THE IMPORTANCE OF GREATER AWARENESS FOR ITP.

PDSA STAFF AND OUR MEDICAL ADVISORS CONTINUED TO ANSWER PATIENT/CAREGIVER CALLS AND EMAILS VIA OUR ITP HELPLINE. THIS WAS ALL IN ADDITION TO PDSA'S REGULAR PROGRAMS AND RESOURCES, INCLUDING THE ITP POKE-R-CLUB FOR KIDS, COLLEGE SCHOLARSHIP PROGRAM, UPDATING AND TRANSLATING NUMEROUS EDUCATIONAL BOOKLETS, AND PRODUCING A 28-PAGE QUARTERLY NEWSLETTER AND MONTHLY E-NEWSLETTER.
