PROPOSALS MUST INCLUDE BUDGET AND USE OF FUNDS. TWO AWARDS OF \$20,000 EACH ARE GIVEN ANNUALLY. PROGRESS REPORTS ARE REQUIRED. RESEARCH FINDINGS IS PRESENTED AT THE ANNUAL ITP CONFERENCE.

IN 2017, PDSA ESTABLISHED A RESEARCH PROGRAM TO SUPPORT EXCELLENCE IN ACADEMIC ITP RESEARCH FOR UNDERGRADUATES, MEDICAL OR GRADUATE STUDENTS INTERESTED IN THE LABORATORY OR CLINICAL STUDY OF IMMUNE THROMBOCYTOPENIA. ONE \$10,000 SCHOLARSHIP IS AWARDED ANNUALLY.

BOTH RESEARCH PROGRAMS ARE REVIEWED AND SELECTED BY A COMMITTEE COMPRISED OF PATIENTS AND PDSA MEDICAL ADVISORS.
